By-law 06-2023

A By-law to Adopt the Estimates for General Purposes for the Municipal Corporation of the County of Northumberland for the Year 2023

Whereas the *Municipal Act, 2001, S.O. 2001, c. 25,* as amended, Section 289, Subsections (1) and (2) provides that the council of an upper tier municipality shall in each year, prepare and adopt estimates of all sums required during the year for the purposes of the upper tier municipality, including amounts sufficient to pay all debts of the upper tier municipality falling due within the year, amounts required to be raised for sinking funds, retirement funds and amounts in respect of debentured debt of lower tier municipalities for the payment of which the upper tier municipality is liable and amount required by law to be provided by the upper tier municipality for any of its local boards excluding school boards. The estimates shall set out the estimated revenues and expenditures in such detail and form as the Minister may require;

Now Therefore Be It Enacted as a By-law of the Council of the Corporation of the County of Northumberland as follows:

- **1. That** the total estimated expenditures for the general purposes of the Corporation for the year 2023 be adopted in the amount of \$213,488,513;
- **2. That** the total estimated revenues for the general purposes of the Corporation for the year 2023 be adopted in the amount of \$213,488,513; and
- **3.** That Schedule "A" providing the estimates of the 2023 expenditures and revenues shall form part of this by-law.

That By-law 06-2023 be introduced and be deemed to be read a first, second and third time, passed, signed and sealed this 25th day of January, 2023.
