"Whereas there is an unprecedented national housing affordability crisis nationally; and

Whereas there is no for-profit supply-only trickle-down solution to ending the national housing affordability crisis; and

Whereas substantial investments in ensuring the use of housing for homes are required to help end the national housing affordability crisis; and

Whereas substantial investments in new affordable social housing are required to help end the national housing affordability crisis; and

Whereas substantial investments in revitalizing existing affordable social housing are required to help end the national housing affordability crisis; and

Whereas substantial investments in social support expansions are required to prevent families choosing between housing and other basic necessities of life to help end the national housing affordability crisis; and

Whereas the national housing affordability crisis is most acute in Ontario; and

Whereas unlike most Provinces and Territories in Canada, 47 Service Managers and District Social Service Administration Boards (SM/DSSAB) are responsible for delivering social supports, including housing affordability supports in Ontario; and

Whereas many of these 47 SM/DSSABs in Ontario are larger than many provinces and territories in the country; and

Whereas these 47 SM/DSSABs in Ontario lack the revenue and policy tools and powers of the Provincial and Federal governments to end the housing affordability crisis; and

Whereas any reductions in funding from the Federal and Provincial governments risks the termination of critically needed housing and social supports for some of the most vulnerable across Ontario;

Now Therefore Be It Resolved That County Council, having considered Report 2024-064 'National Housing Strategy Funding Interruption', authorize the Warden to advocate to the Federal and Provincial governments that the funding dispute must be resolved to limit mounting harms to some of Ontario's most vulnerable families; and

Further Be It Resolved That County Council authorize the Warden to send urgent correspondence to the Federal and Provincial Ministers of Housing to confirm that financial support will continue for vulnerable households across Ontario currently in receipt of the Canada-Ontario Housing Benefit prior to May 31, 2024; and

Further Be It Resolved That County Council authorize the Warden to advocate to the Federal and Provincial governments to continue to fund SMs/DSSABs an amount equivalent to the monies under the CMHC-Ontario Bilateral agreement in the National Housing Strategy until a new funding agreement can be reached; and

Further Be It Resolved That County Council authorize the Warden to advocate to the Federal and Provincial governments to establish a trilateral table including the SMs/DSSABs, to negotiate the final 3-year tranche of funding under the National Housing Strategy."

Assessing the housing crisis: Status quo or emergency response?

CREATING HOUSING AT HIGH SPEED.

THE EVOLUTION OF MANUFACTURED HOUSING IN ONTARIO, IN CANADA + IN THE GLOBAL MARKETPLACE.

WHERE WE ARE.

FRAMING THE PROBLEM.

- With the median household income at only \$91,000 CAD, and the average home price of 1\$M, the resulting mortgage payment represents <70% of the gross median income of an average household.
- < 20% of Canadians spend more than 30% of their income on shelter, in Northumberland it is 18.5%
- 1,000 people in total were on a waitlist for affordable housing in Northumberland County in 2022. Northumberland County Housing Corporation
- The average wait time for NCHC subsidized housing is **7 years** in Northumberland County. Northumberland County Housing Corporation
- 319 people were added to the that waitlist in 2022, and increase of 300%. Northumberland County Housing Corporation



Purpose

The purpose of this report is to appoint a representative of the shareholder to act on its behalf at the Northumberland County Housing Corporation (NCHC) June 6, 2024, Annual General Meeting in the confirmation of Corporate Directors.

Background

This report builds on the notification of the June 6, 2024 Annual General Meeting (AGM) that was provided to County Council as shareholder through correspondence sent to the Warden in April 2024.

The NCHC was incorporated on December 14, 2000 pursuant to the Business Corporations Act (Ontario) (the OBCA) under the authority of the Social Housing Reform Act, 2000 (the SHRA). The Corporation's sole shareholder is the County of Northumberland and currently owns 373 units of social, affordable, and market housing.

The sixth annual NCHC Annual General Meeting has been scheduled for Wednesday, June 6, 2024 at 1:30 p.m. via videoconference. There will be 9 directors continuing in their role as Director on the Board from last year, in addition to the new County Council representative, Mandy Martin. In addition, two new directors will be formally confirmed by the Shareholder as approved in January 2024. The 11 Directors being confirmed are:

It is anticipated that at the AGM, the NCHC Board of Directors via resolutions will appoint an auditor for the 2024 fiscal year, confirm positions of officers of the corporation, including the election of Secretary and appointment of a new General Manager, and approve the 2023 audited financial statements.

Warden Brian Ostrander has confirmed attendance to bring remarks from the Shareholder to the NCHC Board. In addition, the 2023 NCHC Annual Report will be presented and will then be brought to County Council to receive as information, in accordance with the Shareholder Direction.

Consultations

Internal consultations have taken place with key departments including Finance, the Chief Administrative Officer, Corporate Services, and Communications. In addition, external consultations have occurred with the NCHC Board of Directors.

Legislative Authority / Risk Considerations

The NCHC was incorporated under the authority of the SHRA which gave Service Managers the ability to create local housing corporations. This authority was not included in the Housing Services Act, 2011 (the HAS). As an incorporated entity under the OBCA, the NCHC is required to remain in compliance with the Act.

Discussion / Options

Northumberland County appointed a skills-based board on June 24, 2019. Over the last four years the NCHC Board and County staff have made significant strides in supporting the County's strategic priority of affordable housing and have completed a 5-year strategic plan.

The NCHC AGM is open to the public and interested Members of Council.
