Purpose

This report has been prepared in response to County Council Resolution 2025-01-30-058 'Discretionary Services Review'. This report provides a summary of the healthcare services that have been downloaded from the Province of Ontario to Northumberland County and discretionary healthcare funding provided by the County.

Background

Council Resolution 2025-01-30-058 asked staff to prepare a report "regarding County spending on programs/services that were downloaded from the Province."

This report will focus on the Healthcare Services that were downloaded by the Provincial Government to the upper tier municipalities like Northumberland. The transfer of various healthcare services has meant that municipalities like Northumberland have taken on the responsibility of administering these programs and services and the cost of all (or part) of the provision of these programs/services. From the perspective of a taxpayer, this has meant increased pressure on property taxes to pay for these programs and services that were once paid for from Provincial revenue sources, and the financial impact on the County of Northumberland.

The County will be participating in a survey conducted by the Association of Municipalities of Ontario (AMO) about how the 444 Ontario municipalities are "filling gaps in the health-care system with significant investments from the property tax base." AMO hopes to have responses by mid-May, with subsequent utilization for evidence-based advocacy.

Financial Impact

As displayed in the matrix above there have been significant increases in both County and Provincial contributions to the noted healthcare-related services. Funds provided for some of the services such as hospital grants and the Port Hope Walk in clinic are discretionary and outside the scope of mandatory services to be provided by the County. The Provincial contributions represent annual funds provided directly to the County for the Provincial proportionate share. The Province does contribute towards financing services of public health and for hospital operations. These funds are provided directly to the service providers based on their specific funding agreements.

The chart below displays the total proportionate shares of funding by year:

The Provincial share relative to the County increased in 2023 with the implementation of Community Paramedicine and Community Paramedicine LTC programming. This funding is currently committed until March 31, 2026 and the ability to sustain these services subsequent to this is unknown. In 2025, there is a significant increase to the County portion of funding for the Golden Plough Lodge (GPL) long-term care home primarily as a result of debt-servicing costs commencing for a partial year on capital costs for redevelopment of the new GPL. The full extent of this will be realized in 2026 representative of \$7.1M annually over a 20-year term. Although the Province provides an annual construction funding subsidy and basic care per diem over 25 years this is estimated to be only \$1.5M per annum. Provincial per diem funding envelopes do increase related to operations based on the increase in resident beds from 151 to 180 in the new facility; however, this is not significant enough to cover the incremental increased operating costs resulting in an increased County contribution from the levy.

Member Municipality Impacts

There are no direct impacts on the member municipalities because the downloaded services are unique to the upper-tier. The costs of the downloaded programs/service and contributions to discretionary health care funding have increased levy requirements for the taxpayer at the upper-tier level.

Conclusion / Outcomes

The total amount of 2025 levy that is estimated will be necessary for the provision of the downloaded programs of Health Services and County contributions towards discretionary health care financing is \$24,040,249, with the Provincial contribution of \$27,294,733.
