








## Cobourg Traditional Land Acknowledgement

# How we got here today - continued

- July 4, 2022 Special Council Meeting At the June 27, 2022 Regular Council Meeting, Council called the Special Meeting on Sheltering and Homelessness and the Enforcement of Municipal By-laws in Cobourg.
- As part of the Special Council meeting, Town Council heard delegations from ten (10) Cobourg/County Residents on the Sheltering and Homelessness and provided Council with some comments and considerations to consider.
- July 4, 2022 Special Council Meeting Council received a Staff Report on Sheltering and Homelessness and the Enforcement of Municipal By-laws which included two options for Council consideration as well as the role of the County of Northumberland and some programs and a revised detailed Encampment Enforcement Response Plan on the first engagement with persons sleeping rough in Cobourg Municipal Parks.
- July 4, 2022 Special Council Meeting Council also received a Notice Motion from Councillor Beatty on the development of a Encampment Response Plan for the Town of Cobourg.
