### 14.a Proclamation, 'Amyloidosis Awareness Month' - March 2024

"Whereas March is Amyloidosis Awareness Month, a month dedicated to raising awareness, funding research, and supporting those living with amyloidosis and their loved ones; and

**Whereas** Amyloidosis is a group of diseases that occurs when an abnormal protein, known as amyloid, builds up in the tissues and organs of the body, and if left untreated, the disease can result in organ failure and can be fatal; and

**Whereas** Amyloidosis can mimic the signs and symptoms of more common medical conditions and the disease can be challenging to diagnose; and

**Whereas** Amyloidosis often affects people who are older or middle aged; however, younger people have been diagnosed with this disease; and

**Whereas** some of the signs and symptoms of amyloidosis can include shortness of breath, weight loss, fatigue, swelling in the ankles and legs, numbness in the hands and feet, foamy urine, carpal tunnel syndrome, bruising around the eyes, and an enlarged tongue; and

**Whereas** early diagnosis can lead to better outcomes for both patients and their families; and

**Whereas** raising awareness about all the amyloidosis diseases, including hereditary and non-hereditary forms of the disease, can contribute to the building of healthier communities across Canada;

**Now Therefore Be It Resolved That** I, Warden Brian Ostrander, on behalf of Northumberland County Council, do hereby proclaim the month of March 2024 to be 'Amyloidosis Awareness Month' in Northumberland County."



   310 Division Street, Cobourg for use as a shelter.
- December 4, 2023: County and Transition House announce Partnership to modernize shelter services at 310 Division Street and launch community engagement to inform plans.
- January 24, 2024: Council directs staff to provide a report on the thematic analysis of feedback gathered.
- **February 23, 2024:** Engagement activities conclude.
- March 14, 2024: Report submitted to Council.

# Recommendations



### 1. Modernized shelter services

- Implement progressive shelter services and collaborative partnerships for wrap-around services.
- Engage with communities of practice and shelter networks to stay abreast of best practices.
- Examine ownership models for 310 Division Street for optimal asset management and oversight.

### 2. Enhanced community services

- Advocate to other levels of government for expansion of mental health and addiction services.
- Assess opportunities to continue expanding homelessness services to additional municipalities.
- Devise a system response for people for whom shelter is not suitable.

# 3. Transitional and affordable housing

- Expedite plans for transitional housing at 310 Division Street.
- Continue with rapid expansion of affordable housing housing to mitigate pressure on system.

# 4. Community safety and well-being

- Implement measures to address safety concerns in vicinity of shelter. Eg:
  - Enhancing lighting, fencing, and installing security cameras at 310 Division Street.
  - Considering design of outdoor programming/ gathering spaces as pertains to security of the building and neighbourhood impacts.
  - Exploring engagement of professional security services for the property.
  - Supporting neighbourhood clean-up initiatives.

# 5. Operational management

- Assess staffing ratios against best practices and review staff training plans to ensure alignment with evolving needs of clients.
- Ensure building maintenance meets Town property standards bylaw.

# 6. Community engagement

 Establish a Community Liaison Committee to foster collaborative approach to supporting clients and resolving community concerns.

# 7. Awareness and education through information-sharing

- Share consistent communications to raise awareness about services and foster understanding of challenges faced by people living unhoused.
- Provide opportunities for community members to volunteer, offer services, and otherwise engage with the shelter.

# 8. Addressing Service User needs

 Address identified gaps through partnership, such as need for enhanced legal services, improved access to primary care, greater employment supports.

# 9. Legal agreement and commitment


 Establish (a) legally-binding agreement(s) between the County, the Town of Cobourg, and/or Transition House Shelter to clarify roles and responsibilities for successful delivery of emergency shelter services.

### Northumberland County and Kawartha Pine Ridge District School Board finalize sale of school board property to continue advancing plans for more affordable housing

Cobourg, ON – March 15, 2024 – Northumberland County and the Kawartha Pine Ridge District School Board are announcing today finalization of the successful negotiation and acquisition of a 14-acre parcel of land located at 699 Westwood Drive and 637 Burwash Street, in Cobourg. The sale is another significant step forward in Northumberland County's efforts to address the pressing need for affordable and attainable housing.

The property, previously owned by the Kawartha Pine Ridge District School Board, was declared surplus by the board and placed on the market for sale under the requirements of Ontario Regulation 444/98. Northumberland County purchased the property for \$1.5M, with another \$250k per developable acre of land – up to 10 acres – to be paid following environmental assessments, for a total investment at or below \$4M.

"This acquisition underscores our commitment to meeting the housing needs of residents by creating the conditions to actively increase the local stock of affordable housing," states County Warden Brian Ostrander. "By strategically acquiring this property, we are taking proactive steps to build a stronger, more resilient community. As new affordable housing projects are proposed and funding is secured, having this land at the ready will expedite progress to make more affordable and attainable housing options available."

The negotiation process, which began in October 2023 following

direction from County Council, involved planning and consultation between the County and the school board to best understand the land's potential for housing development, along with detailed consultation with the Town of Cobourg and the Ganaraska Region Conservation Authority. The future development of the 14 acres, adjacent to Westwood Park, is subject to standard zoning and environmental reviews.

"We are pleased to have reached this agreement with Northumberland County for the sale of the Westwood Drive property at fair market value," commented Jaine Klassen Jeninga, Chairperson, Kawartha Pine Ridge District School Board. "This transaction not only furthers our shared goals of community development but also ensures that the land will be utilized to benefit the residents and community of Northumberland."

Northumberland County is the sole shareholder of Northumberland County Housing Corporation (NCHC) – the primary provider of affordable housing services in Northumberland. The NCHC presently manages 373 geared to income and market rate affordable housing units. The acquisition of 699 Westwood Drive represents a significant opportunity for future partnership between the County and NCHC to further address housing affordability and accessibility in Northumberland; building inclusive communities where every resident has access to safe, affordable housing options.
